## Guidance notes for applicants for a Lourdes Bursary Award

- 1 These guidance notes are designed to assist you to make an application for a Lourdes Award.  
They should be read in conjunction with the *Lourdes Application form* (GDPR). Please note especially that all applicants:
  - a. must be Roman Catholic or a member of a faith that is in full communion with Rome.
  - b. must be a minimum age of 16 and under 25 at the time of the pilgrimage. Applicants who are in Year 11 and who will become 16 by 31st August in the year of the pilgrimage will also be accepted.
  - c. must also be involved in caring for assisted pilgrims, not simply going on a pilgrimage to Lourdes.
- 2 The application must be physically signed by the two referees requested on the *Lourdes Application form*.
- 3 All awards are made entirely at the discretion of the Trustees of the Bursary Fund.
- 4 The Catenian Bursary Fund cannot provide direct funding for another charity.
- 5 Grants are not given retrospectively. The dates of the Trustees' forthcoming meetings are shown on the *Lourdes Application form*. Please ensure you apply in accordance with the timescales shown in note 6.
- 6 The Application must be completed and received by the Administrator **THREE WEEKS** before the date of the Trustees' next meeting **AND** no less than **TWO MONTHS** before the pilgrimage is due to start.
- 7 All sections of the *Lourdes Application form* must be completed as fully as possible. Where you can't complete the form you must give us clear reasons why.
- 8 If an award is accepted, the applicant agrees that he or she will have no claim against the Catenian Bursary Fund Ltd arising from the provision of this award.

- 10 Completed forms are to be returned, by post, to the Bursary Administrator whose address and telephone number is shown at the end of the form, or at the top of this page.
- 11 It is a condition of this award that you provide the Fund with a report, either as a written, illustrated document, (maximum length 2 x sides of A4), or as a video report on your pilgrimage. This should be sent to arrive with the Fund within 28 days after the end of your pilgrimage, to: [admin@catenianbursary.com](mailto:admin@catenianbursary.com).

Please also send us your pictures – as high a resolution as possible – to the same address, and please send them as stand alone jpegs and do not embed them in your report. You can also upload your pictures to our social media channels.

In completing the application process for an individual Project Award, you will be sharing your personal information with us. We will ensure that all data held on our database is treated in accordance with these principles. Please rest assured that we will never sell or misuse any personal data, or use it in any manner that is inconsistent with our aim of supporting the development of Catholic youth worldwide. We do not intend to contact you too often; we merely need your formal agreement for us to use your data to establish routine correspondence.
