DATA PROTECTION CERTIFICATE

Both the Catenian Bursary Fund Limited and the Catenian Association Limited are bound by the *General Data Protection Regulations (May 2018)* to ensure that any data we hold on individuals is relevant, accurate and not excessive. Additionally, it must be fairly and lawfully processed, held for defined purposes, be accurate and up to date, not kept for longer than necessary, processed in line with your rights and must be secure. We will ensure that all data held on our database is treated in accordance with these principles. Please rest assured that we will never sell or misuse any personal data, or use it in any manner that is inconsistent with our aim of supporting the development of Catholic youth worldwide. We do not intend to contact you too often; we merely need your formal agreement for us to use your data to establish routine correspondence and to receive, account for and bank your financial donations to the Fund.
